2017 Emerging Leaders of Waukesha County:

Taylor Jannsen

Owner – PerformanceMax Basketball Training, LLC

Why he won: Passion, energy and work ethic are common words that come to mind when people talk about Taylor Jannsen. As a coach, lead trainer, author, motivational speaker and business leader, Taylor has changed the lives of hundreds of youth athletes, coaches, parents and businesses with his authentic and lively approach and his contagious enthusiasm. In early 2015, Taylor was diagnosed with testicular cancer and would later undergo chemotherapy treatment. He recalls this time as one in which he began to realize the influence he was having on the players and communities that he worked with. It was also during this time that he began to author his first book, *Leave Better Than Found*. Taylor has since authored his second book, *Wisdom from the Rocking Chair*, and now brings his energy, perspective and passion to the basketball court as well as numerous organizations through his speaking engagements.

Patrick McNally

Director of Critical Care and Emergency Services – Froedtert & The Medical College of Wisconsin Community Memorial Hospital

Why he won: Patrick brings a stellar resume, a strong work ethic, a desire to grow professionally, a passion to give back to others and a plethora of exceptional leadership traits. In addition to his work, Pat supports the nursing profession in general and is active in the community. Recently, he served as a board member and committee member for the Wisconsin Nurses Association and, in 2013, Pat represented the American Nurses Association as part of their house of delegates.
