#### A BRIEF GUIDE ON THE TECHNICIANS APPROACH WHEN DISINFECTION IS NEEDED

Purpose: To provide Paul Davis employees with guidance and education for cleaning, disinfecting and proper PPE regarding the COVID-19 virus (Coronavirus).

**Phase I** – An initial assessment of the facility and development of a written Response Plan. The plan would include coordination with the facility management. The plan review and acceptance form the basis of the working emergency response actions.

**Phase II** – Ready Status – Once alerted by the appropriate facility staff, Paul Davis would dedicate resources (decontamination equipment and supporting products) to the facility. Documentation of all actions and proposed protocols for a given situation would be reviewed, maintained and readily available to the facility coordination team.

**Phase III** – Mobilization of equipment and personnel to coordinate and begin decontamination activities as directed by the Site-Specific Plan and the facility's response team. Documentation of all actions taken, disposal of waste products, equipment decontamination, would be provided to the facility's coordination team for records and distribution as they deemed appropriate.

### PROPER PERSONAL PROTECTIVE EQUIPMENT

Paul Davis employees encounter a variety of bacteria, molds, viruses and pathogens daily. For example, mold remediation and sewage cleanups have the potential to expose employees to a variety of hazardous substances. By selecting the proper PPE, correctly wearing the PPE selected and disposing of potentially contaminated PPE, Paul Davis employees take the necessary steps to protect themselves on each and every job. The Cleaning and Disinfecting process for the Corona virus should be treated in the same manner as Cleaning and Disinfecting for a Category 3 loss or a mold remediation. If we follow the proper protocols during these steps, we will set the job up for a proper decontamination phase.

- 1) An N-95, half face respirator with N-95 cartridges or full-face respirator with N-95 cartridges.
- \*Everyone needs to have a respiratory medical exam to wear these. OSHA3789info.pdf
- 2) Eye protection either Safety glasses or a splash shield.
- 3) Hand protection some type of disposable nitrile/latex gloves.
- 4) In some cases, such as hospitals, senior homes were the virus has already made it presence known a Tyvek suit will be necessary.

PPE should be donned and doffed appropriately. Proper disposal of potentially contaminated PPE is critical to protect employees and any other structure they may enter. Respirators should be cleaned according to manufacturer's instructions upon every use and stored according to OSHA guidelines when not in use.

\*OSHA dictates that anyone that uses a respirator, must be medically cleared and fit tested prior to wearing one\*
